- 1. The Chairman welcomed all to the meeting and accepted apologies.
- 2. The minutes from the last AGM, held on 12.07.21 were agreed and signed.
- 3. There were no matters arising from the previous meeting.
- 4. <u>Chairman's report</u> copies were circulated to members of committee and public. A copy is on file for information. Questions were invited- none were raised.
- 5. <u>Treasurer's report</u> copies were circulated to members of the committee and public. A copy is on file for information.

Sandra gave a commentary on costs for the refurbishment of the kitchen:

Total costs up to 31.03.22 including equipment, fixtures, and fittings £12,462.

Sandra made a correction to information given at the last meeting – the profit from the Kings of Swing event was £239.40 and not £90.33 as previously reported.

Sandra itemized the income for the village hall up to 31.03.22, totaling £9,579.72 The hall made a net loss of £9,193.

Current funds available total £12,626.02 (including funds in the bank and petty cash)

Questions were invited and several were raised by members of the public:

- Does the hall pay for grass cutting? only near the tennis courts, the Parish Council is responsible for the playing field.
- Is it usual to have such a high value of donations? varies from year to year
- Are bids submitted for available grants? yes, bids are submitted with some success. We are awaiting a grant of £4,000 from the Pagan Trust which was agreed in 21/22 financial year but will be received during 22/23.
- Does the hall usually make an annual profit or loss? Usually makes a profit but recent income has been reduced due to closure during Covid pandemic and slow return for bookings. Ticketed events usually make a profit.
- Is the income from the recent coffee mornings included in the figures presented? all events up to 31.03.22 are included.

6. <u>Alburgh bar report</u> – the report for the period ending 31.12.21 was not available at this meeting, though it has been audited and confirmed. Julie reported that events have been very successful since Jason Collins began supporting the provision of food (income from food is included in the figures in the Treasurer's report).

Questions were raised by members of the public:

- What are the staffing costs for the bar? none as all bar staff are volunteers. The only staff costs are for the caretaker, and these are met by the village hall (see Treasurer's report).
- Is the profit from the bar shown in Treasurer's report? no as the bar is separate from the Village Hall. Any profit from the bar is re-invested in the hall via donations as needed e.g., contribution towards kitchen refurbishment.

Julie estimated that the closing balance for the bar at 31.12 21 is in the region of £5,000, with a further £1,500 profit taken since then. A donation towards the costs of redirecting drains to prevent flooding in the car park ran the bar finds down last year.

A member of the public, who is relatively new to the village, wished to record their thanks for doing a "fantastic job" since the bar re-opened in August 2021.
